## **Declaration –**

I hereby confirm my participation in the Tour/Treks facilitated by Temple Darshans and shall abide by the following terms:

- I release Temple Darshans Company and its employees, agents, officers, guides, licensees, representatives, and the land management authority in the country in which the trip is conducted (each of whom are collectively referred as "Temple Darshans and its employees")

From liability, cost, loss or damage incurred or suffered by you directly or indirectly during the course of the trip and resulting from your personal injury, illness or death or damage to or loss of your property unless caused by the willful negligence or wrongful act of Temple Darshans and its employees.

- II. I waive any claims you have, or may at any time have, against Temple Darshans and its employees and you agree, by accepting the additional inherent dangers and risks associated with the trip, not to make any claim against or seek any compensation from Temple Darshans and its employees in respect of any personal injury, illness or death suffered by you or damage to or loss of property sustained by me as a result of your participation in the trip. I understand that I am traveling at my own risk.
- III. I understand and accept that due to the nature of travel in mountains and also due to certain tours and conditions imposed upon Temple Darshans by the principals i.e., the Chinese travel authorities, I will not be eligible for any refund of the cost for whatsoever reason when the trip is actually launched, and if I make a cancellation after completing booking formalities I lose the amount mentioned in the cancellation policy.
- IV. I understand that I am liable to pay Temple Darshans the remaining amount for the tour before 35 days of departure. If I do not make the payment then my tour will be automatically cancelled and lose the amount mentioned in the cancellation policy (See Section 4).
- V. I also understand that in case of any cancellation of the tour by me under unforeseen circumstances, I will not be eligible to be able to get any sort of refund from Temple Darshans.
- VI. I understand that passport must be valid for at least six month from the date of my departure date from Kathmandu/ Lucknow.
- VII. I have read all the Terms and Conditions listed in this booking form thoroughly and fully understood the information of the trip. Also, I have understood the itinerary and all other written material issued by Temple Darshans for the trip that I have applied to join.

## Terms and Conditions(Please Read Carefully)

In completing and submitting the Booking / Registration Form, you agreed to be bound by the sections which constitute the agreement between Temple Darshans and you. These conditions apply to the exclusion of any other terms or conditions unless they are set out in the Booking Form or are otherwise agreed to in writing by the parties. Previous dealings between the parties will not vary the sections. No claimed variation of these conditions will be effective unless in writing and signed by a person so authorized by Temple Darshans.

### 1. BOOKING AND ADVANCE DEPOSIT

Advance Deposit of USD 300 / INR 15,000 per person. If you cancel your Trip 60 Days prior to travel date; we will refund your Full amount except INR 11000 / USD 200 as office admin and booking process charges.

### 2. PAYMENT

a) **Full Payment Requirement:** Travelers must pay the entire trip amount before departure to begin their journey

b) **Payment in Indian Currency:**

- If you opt to pay in Indian Rupees (INR), the payment will be converted based on the current exchange rate of 1 USD = 90 INR.
- If the USD-INR exchange rate rises by the departure date, you will need to pay the difference to account for the increased cost.

c) **Transactions in USD:** Since transactions in Tibet are processed in USD, any fluctuation in exchange rates directly affects the amount payable in INR.

### 3. GENERAL POLICY

Our top priority is ensuring that you enjoy your holiday and that we earn your trust. However, we are not responsible for any cancellations arising due to:

**A. Responsibility Limitations:** The Company is not liable for cancellations due to industrial disputes, transport failures, force majeure, late arrivals, loss of earnings, or other uncontrollable factors or similar unforeseen issues.

#### **B. Cancellation Process:**

- Cancellation requests must be made in writing to Temple Darshans.
- Charges and refunds depend on the timing of the cancellation:

#### **Cancellation Timeline & Charges:**

##### **1. 60 Days or More Before Departure:**

- Refund: Full payment refunded.
- Deduction: INR 11,000 / USD 200 per person (administrative/booking charges).

##### **2. 60–45 Days Before Departure:** Refund: Remaining balance refunded after the following deductions:

- INR 1,25,000 / USD 1,340.
- Additional INR 11,000 / USD 200 (admin charges).

##### **3. Less than 45 Days Before Departure:** Refund: Remaining balance refunded after the following deductions:

- INR 1,35,000 / USD 1,700.
- Additional INR 11,000 / USD 200 (admin charges).

**Effort to Reduce Charges:** The Company will try to minimize cancellation charges where possible.

**4. No-show or Cancellation after Arrival at the Starting Point:**

- Non-refundable: Full payment is forfeited.

**5. Unforeseen Circumstances** (e.g., new entry rules, natural disasters, political issues, epidemics):

- Refund: Full payment refunded, excluding INR 11,000 / USD 200 per person (admin charges).
- Adjustment Option: The amount can be adjusted for future Kailash travel plans.

**1. Modifications to the Itinerary:**

- Changing the departure or conclusion date of the trip.
- Modifying routes or objectives in the itinerary.
- Substituting alternative or equivalent routes for cancelled or modified segments.

**2. Postponement or Cancellation:**

Trips may be postponed, cancelled, or delayed due to:

- Adverse weather, snow, or icy conditions.
- Hazardous, dangerous, political, military, or terrorist conditions.
- Likelihood of such events that may endanger participants.
- Acts or omissions by third parties that prevent the trip from proceeding as planned.
- Changes in government travel warnings or advice.

**3. Impact on Refunds and Compensation:**

- In the event of any changes, postponements, cancellations, or delays, you acknowledge:
- No entitlement to a refund (in whole or in part).
- No right to claim compensation for injury, loss, damage, or additional expenses arising from these changes.

**5. Binding Resolution:**

- Any differences or disputes arising during the trip will be resolved with finality by Temple Darshans.

**Jurisdiction and Compliance Policy:**

**1. Jurisdiction:** Any legal matters or disputes related to this trip will be subject to the exclusive jurisdiction of the Lucknow Courts.

**2. Mandatory Compliance:**

- Participants must comply with all formalities and regulations required by Nepalese and Chinese authorities during the trip.
- Non-compliance with these formalities may result in the cancellation of the participant's trip.

**3. Prohibited Items and Actions:** Participants found in possession of unlawful drugs, political propaganda, firearms, or pamphlets will be immediately excluded from the tour without any refund.

## 5. INSURANCE

Personal travel insurance and medical insurance is not included in the trip price.
